YARD SALE VENDOR INFORMATION & RULES

REGISTRATION

- Registration is first-paid, first-served.
- Completing a registration form does not reserve a vendor space.
- Your registration is complete only after payment has been received.
- Paper registration and payment are available at the General Stilwell Community Center.

EVENT DAY CHECK-IN

Vendors must arrive between 5:45 a.m. and 6:45 a.m.

Upon arrival:

- Stop at Vendor Check-In.
- Check in with an event attendant. (Must present ID)
- Wait for an attendant to direct you to your assigned space.

Do not enter the sale area or park yourself.

PARKING NEXT TO ANOTHER VENDOR

If you would like to park next to another vendor:

- Arrive together.
- Check in together.
- Request adjoining spaces when checking in.

Requests cannot be guaranteed if vendors arrive separately.

VEHICLE MOVEMENT

No vehicle movement is permitted after 6:50 a.m.

Vehicles must remain parked until the Event Manager announces the All Clear at the conclusion of the sale.

ITEMS YOU MAY SELL

Examples include:

- Household items
- Clothing
- Toys
- Books
- Furniture
- Home décor
- Tools
- Sporting goods
- Other used personal property

PROHIBITED ITEMS

The following are prohibited:

- Food
- Drinks
- Alcohol
- Drugs
- Commercial merchandise
- Business inventory
- Merchandise purchased specifically for resale without prior approval

VENDOR SPACE

A standard vendor space measures 9' × 18'.

You may bring:

- Tables
- Chairs
- Canopies (Must be weighted down – canopies will be checked at 0650. If not weighted, canopies will be required to be removed.
- Display racks

Everything must fit and remain within your assigned space.

TRAILERS & U-HAULS

Please notify staff during registration if bringing:

- Trailer
- U-Haul
- Oversized vehicle

Additional vendor spaces may be required.

YOUR RESPONSIBILITIES

You are responsible for:

- Your merchandise
- Your guests
- Keeping your area clean
- Removing all trash and unsold items
- Following staff directions

WEATHER POLICY

The Yard Sale is a **rain-or-shine event**.

If severe weather or other unsafe conditions require cancellation, the Event Manager will notify registered vendors as soon as possible.

If DFMWR cancels the event due to severe weather, vendors may transfer their paid registration to the next scheduled Super Garage/Yard Sale.

If the event is held as scheduled and a vendor chooses not to attend, registration fees will not be refunded or transferred.

CHILDREN & PETS

Children under 13 must be supervised.

Service animals are permitted.

Pets are not allowed.

LIABILITY

DFMWR is not responsible for lost, stolen, or damaged property.
