TERMS AND CONDITIONS

1. **PURPOSE:** The resale lot is furnished solely for the convenience of personnel for the sale of their personal vehicles. Any use of this area to further a commercial business enterprise, or to use as storage, is prohibited.
2. **LOCATION:** The resale lot is located on Ord Military Community, adjacent to the Commissary. Park only in the designated location.
3. **ELIGIBILITY:** Only people with a valid DOD I.D. card and vehicles registered in their name (or power of attorney to sell a vehicle for a DOD member) may use the Resale Lot to Display Vehicles. Non DOD may access lot for inspection/purchase of vehicles.

Vehicles to be displayed must be:

Properly registered to the owner (POA will be accepted), with current license plate.

Insured by the owner. Neither the U.S. Government nor the Presidio of Monterey will be responsible for the loss of and/or damage to your vehicle.

Kept clean and in operating condition. Owner will be responsible for any contamination or damage related to the displayed vehicle.

4. PROCEDURES:

- A. Come to NAF Support Services Division at 4260 Gigling Road, Room #5 Seaside, CA 93955 to complete the resale lot registration form with requisite fee and proof of current registration and insurance for each displayed vehicle.
- B. NAF Support Services Division personnel will collect the established fee for this service. The fee is good for a single vehicle for an initial period not to exceed 30 days. This Fee is NOT PRORATED, nor will refunds be given after the first day of display. Maximum displays of 60 days.
- C. Notify NAF Support Services Division (831) 242-6632 when the vehicle is sold, and remove the vehicle on the day of the sale.
- D. Immediately, within 48 hours, correct any safety or procedural violation that MWR staff identify, or remove the vehicle from lot at owner's expense.

5. ENFORCEMENT:

- A. POM Police Department and NAF Support Services Division will periodically patrol the lot to enforce compliance with these procedures. These periodic patrols are not for the purpose of ensuring the safety of the displayed vehicles.
- B. Failure to timely pay monthly fees, maintain current insurance, registration, safety or cleanliness of the vehicle, or any other behavior which makes MWR conclude that continued display is not in the best interests of POM, shall be corrected with 48 hours of notice. Failure to correct or for owner to arrange timely removal of vehicle (within 5 days) will result in MWR having the vehicle towed to an impound lot or sold for scrap, at MWR's sole discretion. Owners shall be solely responsible for the costs of towing and/or storage at an impound lot.
- C. The owner obligation is to let MWR know good address/telephone # at which they can be reached. If they can't be reached at the provided address/number, the owner forfeits notice.

RELEASE OF CLAIMS AND AGREEMENT TO INDEMNIFY

I have read and agree to the terms and conditions above. I hereby release and hold harmless NAF Support Services Division Presidio of Monterey, the United States Department of Defense, and any of their officers, employees, or agents from all claims, including claims for loss or damage to my personal property, causes of action, suits, and proceedings, which I, my heirs, or personal representatives may have now or hereafter for any reason pertinent to my displaying my vehicle on the resale lot at Ord Military Community. I further agree to indemnify any of the persons and organizations named above for any claims or suits against any of them arising in any way from my displaying my vehicle on the Resale Lot.
