- No refunds on any rentals returned unused.
- Cancellations of reserved equipment will not be refunded.
- Gear returned with damages beyond normal usage will be charged applicable fees at discretion of FMWR staff.
- If equipment is returned later than specified return date and time, a full day rental fee will be assessed.
- **Our prices are gauged on customer convenience, lowest possible cost, and *take into account* ODR hours of operation. No discounts or special accommodations will be granted due to ODR operating hours.**
- Patron must set up and inspect equipment upon pick up and return; Patron is responsible for returning *their own* equipment.
- **For all equipment rentals:** All equipment must be returned in same condition as it was rented out (examples: If renting a mountain bike, golf clubs, tent, campstove, skis etc... they must be clean of all mud and debris and in same working order; if renting a surfboard, kayak, wetsuit, or other ocean equipment, they must be rinsed with fresh water and free of sand and saltwater).
