I must have a current ODR Tow Hitch card that specifies the customer vehicle as the only authorized vehicle to tow ODR trailers. If any unapproved vehicle has towed the trailer, any resulting damage to property or injuries shall be the full responsibility of the customer and not Presidio Outdoor Recreation.
